Participant/Player acknowledges that he/she understands the nature of the activities conducted on the premises and is proper physical condition to participate in same. I further agree that Alan Hunter d/b/a Team Airsoft, Team Airsoft contractors and referees and the owners of the Georgetown Field premises near Dawsonville, Georgia shall not be liable for any injuries, losses, expenses or damages occurring as a result and/or arising from participation in activities and/or events at Team Airsoft's Georgetown Field regardless of whether said injuries, losses, expenses and/or damages arose out of negligence or otherwise.
